  - i. The Chief testified at the Colorado State Capitol on SB 194.

  - iii. Academy graduation occurred on May 3<sup>rd</sup>. Great collaboration with the District, BFFR, and the college.
  - iv. Applications are now being accepted for the 2025 firefighter eligibility list.
  - v. The District used the drone yesterday on a medical call at Eagle Rock Distribution Center. The drone has a speaker with infrared capabilities and can carry a small payload. It is the same drone as CSFD, and both agencies have participated in interagency training.
  - vi. The District received its first Lucas device with future plans to have one on each ambulance.
  - vii. The District participated in 667 training hours.
  - viii. CSFD to create an "enterprise" service for ambulance transport.
  - ix. The District plans to replace the small tender, but it will take 18-24 months to build.
  - x. The new tower ladder is scheduled for delivery in Oct.
  - xi. The Station 2 remodel project will be ready for permitting in September.
  - xii. Station 4 received a new apron.
  - xiii. The Station 4 remodel project is scheduled to be completed by September.
  - xiv. DV Bumgarner and Lt. Leonhardt are at the "Station Design" Conference in Phoenix this week
  - xv. More neighborhoods were added to the chipping program this year, and the crews are using two chippers to double up the days
