






Incidents by Call Type – November






Incidents by Call Type - December





Incidents – Top 3 Response Categories – November






Incidents – Top 3 Response Categories - December




Ambulance Transports - November






Ambulance Transports - December




Ambulance Automatic/Mutual Aid - November












Month-to-Month Comparison – Total Incidents – November







Month-to-Month Comparison – Total Incidents - December




Year-To-Date Comparison – 2022/2023 – November









Administration – Division Chief Jamey Bumgarner

Summary of Significant Events:

- The final inspection of the new Type 3 Engine was completed.

- Fire Station 3:
 - MFD, NV5, OZ, and the developer met with Town Planning & Engineering on 10/27/23 to introduce the "project" and to seek feedback about the subdivision and public improvement process.
 - The town advised that a plat, public improvement agreement, and subdivision improvement agreement will be required of the developer/seller.
 - The developer/seller must also complete a major subdivision process. This entire process is estimated to take 6-9 months.




- The seller and MFD have been negotiating the purchase and development agreements. The sale price will be fixed at fair market value, and an updated appraisal will be required before closing. The board will be asked to review and take action on these agreements in the February board meeting.
- O MFD and our owner's representative (NV5) will meet to revise the program plan for the project and kick off the design phase with a charette. This will be an all-day, immersive experience, and the attendees will learn more about fire station design best practices and participate in work sessions to define the needs and operations requirements of the site and each building component. NV5 will coordinate the attendees list with the Fire Chief.

Accreditation – Accreditation Manager Scott Ridings

Genysas EVAC, formerly Zonehaven, has been implemented and is operational to inform
residents of any needs during an emergency. Genysas Protect EVAC enables responding
agencies to react swiftly, make collaborative decisions, and communicate event status in realtime to dispatch, other agencies, businesses, and the public during an emergency. Determining
and communicating the proper scope of a response or evacuation, replacing guesswork with
data-driven intelligence. With EVAC, it enables faster and more precise emergency response and
evacuation. The Multi-Threat Planning & Modeling tool models behaviors to plan for effective
responses and/or evacuation scenarios covering emergencies like wildfires, floods, active
shooters, hurricanes, and more.






Training hours for January – 628 Training Hours.






Incidents by Call Type – January





Incidents – Top 3 Response Categories – January






Ambulance Transports - January




Ambulance Automatic/Mutual Aid - January








Incidents by Call Type – February










Ambulance Transports - February










Incidents by Call Type – May










Ambulance Transports - May














Incidents by Call Type - August










Ambulance Transports - August




Ambulance Automatic/Mutual Aid – August








Incidents by Call Type - August










Ambulance Transports - August










Incidents by Call Type – September










Ambulance Transports - September




Ambulance Automatic/Mutual Aid – September








Incidents by Call Type – October










Ambulance Transports - October






