- iii. Fire Station 3 Update. The process continues to move forward and is in the hands of the property owner and the Town of Monument.
- iv. Fire Station 6 Land Purchase Update. The fire district submitted information to the property owner and is awaiting a revised land purchase agreement.

IX. New Business

- i. Volunteer Pension Plan Affiliation Agreement.
 - MOTION to approve the Volunteer Pension Plan Affiliation Agreement. The motion to approve the volunteer pension plan affiliation agreement was made by Director Kelly and seconded by Director Garrett. All directors were in favor, with no opposition.
- Discuss 2025 BOD Meeting Times. The board of directors had a discussion on the 2025 BOD meeting times. Director Kelly expressed concern about the overtime cost to the district for staff to attend the meetings after hours. Chief Kovacs shared that he, Chief Bumgarner, and Chief Bradley are exempt and are not eligible for overtime. Other staff members who attend, on average, would receive two hours of overtime once a month only. Director Kelly made a motion to move the 2025 BOD meetings to 4:30 pm. The meetings will continue to be held on the fourth Wednesday of the month. Director Garrett seconded the motion. All directors were in favor, with Vice-President Hildebrandt in opposition. The motion passed.
- X. Chief's Report Chief Coyle provided the Chief's Report, highlighting several areas of interest to the board of directors. Chief Kovacs gave an update on the fire blanket that was purchased to combat fires in electric vehicles and discussed pending ballot measures (Initiative 50 and 108) in November that may impact the district's property tax revenue. Future considerations for sales tax revenue and impact fee collection in the county were discussed. The idea is that the district should not have all its eggs in its basket when it comes to revenue. Chief Bradley provided a recap of the increased calls for service for reported gas leaks. The district will be meeting with Black Hills Energy representatives to discuss how to improve our response and collaboration should a similar event happen in the future.
